

TOWN OF PRAIRIE DU SAC PLANNING COMMISSION RESOLUTION 2021-01

**RECOMMENDING AMENDMENTS AND REPLACEMENT SECOND ADDENDUM
TO THE 2017 SAUK PRAIRIE COMPREHENSIVE PLAN**

WHEREAS, on April 11, 2017, the Village of Sauk City Board, Village of Prairie du Sac Board, and Town of Prairie du Sac Board jointly adopted a complete update to the Sauk Prairie Comprehensive Plan (hereinafter “Plan”), under Section 66.1001(4), Wisconsin Statutes; and

WHEREAS, such adoption included the Highway 12/PF/Airport Area Plan the Plan’s first addendum and the Sauk Prairie Comprehensive Outdoor Recreation Plan 2016-2020 (“CORP 2016-2020”) as the Plan’s second addendum; and

WHEREAS, per the procedures in §66.1001(4), Wisconsin Statutes, in the Plan itself, and in a 2019 intergovernmental agreement among the three municipalities, the Sauk Prairie Intergovernmental Planning Committee (“IPC”) and the individual plan commissions have the authority and responsibility to recommend amendments to the Plan; and

WHEREAS, on June 10, 2021, the IPC recommended amendments to the Plan to incorporate a wellness initiative and to adjust policies for mineral extraction operations in the Town, with such amendments attached hereto as Exhibit A; and

WHEREAS, the Sauk Prairie Recreation Commission has directed a five-year update to the CORP (“CORP 2021-2026”), attached hereto as Exhibit B; and

WHEREAS, the Planning Commission of the Town of Prairie du Sac (“Commission”) has determined that the proposed Plan amendments in Exhibit A and proposed replacement second addendum in Exhibit B are consistent with the vision, goals, objectives, policies, and initiatives within the Plan.

NOW, THEREFORE, BE IT RESOLVED that the Commission hereby recommends that, following a public hearing in compliance with the requirements of §66.1001(4)(d), Wisconsin Statutes, the Town Board adopt an ordinance to constitute official Town approval of:

1. Amendments to the Plan in the manner reflected in Exhibit A.
2. The CORP 2021-2026 as the Plan’s second addendum to replace the CORP 2016-2020.
